



# Testing Flow Chart for RoHS:Cd/Pb/Hg/Cr<sup>6+</sup> /PBBs&PBDEs Testing




The samples were dissolved totally at the acid digestion step of the above flow chart for Cd,Pb,Hg Section Chief : Timothy Jeon
